- Vision - a reporting suite designed for the non-technical user with complete integration to Microsoft Office products such as Excel and Word , allowing the production of powerful management reports and enquiry access to accounting and budgetary information. Vision also links with other applications such as PROACTIS and time@work (see below).
- Flexible scalability to allow for growth (from 1-200 users per system).
- A fast, low risk implementation.
- Integrated links to Document Management Software to greatly improve workflow

- SunSystems Collect - A fully integrated debtor management application that will assist your credit controllers to collect overdue accounts by alerting them, setting up diarised actions, creating statements and dunning letters and e-mailing these and producing DSO and debtor reports.
- SunSystems Recurring Invoicing – A highly flexible contract invoicing module that will produce rent invoices, service charge invoices and other ad-hoc invoices as necessary. This module has a flexible calendar that will allow invoices to be produced on quarter days, calendar month ends, last working day and more. In addition a powerful rules engine allows revenue to be recognised according to your policies, no manual intervention is necessary.
- SunSystems Decision Ware – This module is the ultimate planning tool; at a very simple level it can be used to create annual budgets by setting up a central model to which all budget holders will make a contribution, thus eliminating the need for spreadsheets. At a more advanced level, this can be used for predictive planning and analysis allowing the business to conduct "what if" type scenarios, for example what would be the effect on rental yields if there is 0.25% increase in interest rates, for a particular client.
- time@work – A marketing leading professional services automation (PSA) solution that integrates seamlessly with SunSystems. Functionality includes time and expense recording through a web browser, WIP management, highly flexible billing using a variety of methods, project budgeting, resource management and links to industry standard applications such as MS Project. time@work is a must for any professional services organisation (PSO) that wants to maximise its return on its people or other chargeable resources.
- MAXISUN – A highly flexible and powerful integration engine developed by Sapphire using Microsoft's .NET technology and MS SQL Server. This application can be used to "connect anything to anything". Many organisations have specialist point solutions or legacy systems that they have to retain, MAXISUN allows data maps to be set up between disparate systems and for these to be integrated in a simple yet robust way without the need for specialist programming or development effort.
- Kontrolla – A fully functional modular Document Management System (DMS) with pre-built links to SunSystems and PROACTIS. This application will allow organisations to manage the filing and retrieval of non-structured data such as sales invoices, rental agreements, contracts, purchase orders, purchase invoices and most other paper based documents. Through its links with SunSystems and PROACTIS, documents filed in the Kontrolla library can be displayed at the click of the mouse.

Infor10 (SunSystems) covers all aspects of financial management, including general ledger, multi-currency, dual base-currency, fixed assets, budget management and more. Infor10 (SunSystems) is fully euro compliant - and it supports the specific requirements of the property sector.

At the heart of the Infor10 (SunSystems) solution is a single, integrated ledger that combines the functionality of general ledger, sales and purchase ledger, project ledger, cashbook and user defined ledgers. Flexible Intuitive Reporting

Vision for Infor10 (SunSystems) is a unique suite of applications that allows users to produce highly presentable reports and inquiries quickly and easily, Vision is truly designed for the "non-technical" user. If a user can use Excel then they can use Vision, it uses the same type of logic and design features so little or no training effort is required.

Vision can be used as an enterprise wide reporting application also, not only does it link to the Infor10 (SunSystems) database, it also links to other applications such as PROACTIS, and time@work. There is also the ability to access data from other ODBC compliant databases, thus allowing users to pull data in from different sources. Reports can be produced and output in a variety of different formats including PDF, HTML and Excel.

Vision Alert is an additional application within the suite which can be used to schedule the production and creation of reports and enquiries outside of working hours thus maximising staff and system productivity. Alerts also includes the ability to embed powerful business rules and logic into reports thus allow exception reporting to be automated i.e. produce and e-mail to the Head of Finance an aged debtors report if a particular group of client accounts exceeds 60+ days.
